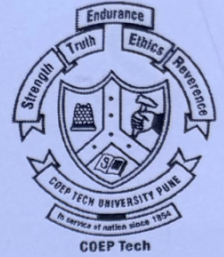
1) Submission of Quotation Documents-

Acceptance of Quotation conditions-

1.1 Envelope should be sealed, and quotation should be addressed to The Director Board of Student's Development, COEP Technological University.

1.2 No quotation(s) will be entertained by E-mail/Fax.

1.3 The last date for submission of the quotation document is **19th January 2026, till 3:00 PM**. Quotations received beyond the closing date/time will not be accepted and will be rejected/unopened.

1.4 Quotation opening date, time and venue will be notified.

2) **All duties, taxes, and other levies payable by the vendor need to be included in the total price, and break up needs to be indicated.**

3) Part delivery will be accepted only on demand.

4) **Delivery will be accepted after prior checking of goods.** Delivery should be done to address mentioned in the purchase order.

5) **No advance payment will be given.**

6) The Institute reserves the right to accept or reject any quotations and reject all quotations at any time prior to the award of the contract, without thereby incurring any liability to the affected vendor or vendors or any obligation to inform the affected vendor.

7) Incomplete quotations will be rejected without consideration.

8) The actual quantity will depend on the Institute's requirements. However, quantity may increase/decrease.

9) If in case any immediate demand (+30%) is created for any deliverable it would be the sole responsibility of the vendor to provide the same as soon as possible and it is to be delivered at the same cost as mentioned in the quotations and no extra charges are to be applied for the same.

10) Also, in case of any curtailment of the given specifications of the deliverable, the charges of the curtailment would be according deducted.

11) **Payment: 100% payment shall be made for the goods only in good condition after completion of the Event.**

12) The detailed terms and conditions regarding the order will be stated in the Purchase order and need to be followed strictly.

13) All interested vendors must possess a valid **PAN card number** and also a **GST number**.
