The work includes Drilling of a New Bore well With All Required Materials, Equipment and Accessories at COEP at Technological University, Chikhali Campus, Pune, as per specifications mentioned in *Annexure-A*.

### **2. Eligibility Criteria**

The bidder must have prior experience in bore well drilling work and possess necessary machinery, equipment, and manpower.

### **3. Earnest Money Deposit (EMD)**

- Each bidder shall submit an **EMD of ₹1,000/- (Rupees One Thousand only)** along with the quotation.
- Bids submitted without EMD shall be **rejected**.

### **4. Submission of Quotation**

- Quotations must be submitted in a **sealed envelope**.
- The envelope shall be superscribed as:
- **“Quotation for Drilling of New Bore well–Tender No. COEP Tech/BWC/Quotation/2026/03”**
- The quotation must be submitted to the **Inward Section, COEP Tech, Pune – 411005**.
- **Last date of submission: 22/05/2026 (Thursday) up to 05:00 PM.**

### **5. Opening of Bids**

- Bids will be opened by the **Tender Committee** on the scheduled date.
- Intimation/notice will be published on the institute website.

### **6. Validity of Quotation**

The quotation shall remain valid for **60 days** from the date of opening.

### **7. Rates and Charges**

- The bidder shall quote **rates inclusive of all charges** such as materials, equipment, and accessories
- Rates once quoted shall be **final and binding**.

## **8. Site Inspection**

- Bidders are advised to inspect the site before quoting.
- No claims arising due to lack of site knowledge shall be entertained later.

## **9. Completion Time**

The work shall be completed within the time period specified in the work order.

## **10. Payment Terms**

Payment shall be made only after satisfactory completion of work and certification by the competent authority.

## **11. Quality Standards**

The work shall be executed as per standard engineering practices and specifications.

## **12. Safety and Responsibility**

- The contractor shall follow all safety norms and statutory regulations.
- Bidder shall be responsible for any accident, injury, or loss during execution of work.

## **13. Damage to Property**

Any damage caused to institute property shall be rectified by the contractor at their own cost.

## **14. Labour and Transportation**

The successful bidder shall arrange **their own labour, machinery, and transportation** required for execution of the work.
